## Chapter 13

### WAR HISTORY

**T**HE UNITED STATES is a peace-loving country and the great majority of her people are bitterly opposed to militarism and war, and yet within the comparatively short period of 100 years since the founding of Mount Morris, our country has been engaged

in three wars, one bloody civil war and two wars with foreign nations. In all three of these conflicts, Mount Morris did her full share and as complete a record as possible is here presented of those who participated in these wars and the regiments to which they belonged.

### THE CIVIL WAR

**I**N the year 1861, as every one knows, the United States was plunged into a long and bloody war—the South pitted against the North in terrific struggle, lasting over four long years. During this time President Lincoln made eleven separate calls for volunteers to help suppress the rebellion. Among the 3,339,748 men who responded to these calls were many loyal citizens from Mount Morris Township, who left their homes and families and risked their

lives in the defense of their country's flag.

After the war, many veterans who had enlisted from other states and localities came to Mount Morris, and the following list includes all soldiers and sailors who either at one time or another lived in Mount Morris, regardless of whether they enlisted from here or not. This list is given in alphabetical order, together with the regiments and companies in which they served.

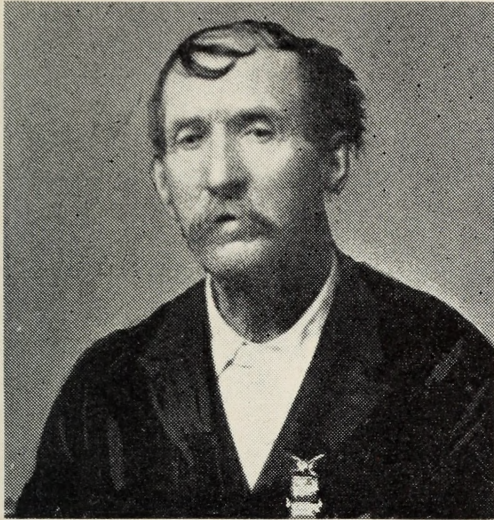

Mr. Holsinger married again in 1875, to Mary Grossnickle, and three children were born to them: Anita (died March 18, 1907), Charles and Lloyd. Mrs. Holsinger died in 1936.

JOSEPH M. HOSKING was a veteran of the Civil War, regiment unknown. He conducted a photograph gallery over Brayton's Drug Store in Mount Morris for about ten years. He died suddenly in his gallery in January, 1896, and Roy Householder, his assistant, took over the business. He was the first commander of the local G.A.R. Post.

March 22, 1848, he married Rachael Buzzard, and to them were born seven children—Samuel, Clinton, Harry, Jacob D., Mrs. John Traister, Mrs. Sanders Bain, and Mrs. Fred Bearman.

CHAS. T. MARSH, who spent his young manhood in Mount Morris, was the son of William Marsh, a sailor with Lord Nelson on the British man-of-war "Victory" at the Battle of Trafalgar, and was born at Dover, England, May 5, 1845. He came with his parents to America when he was ten years old and settled in Mount Morris. Seven years later, at the age of 17, when the Civil War broke out, Mr. Marsh volunteered as a member of Co. K, 92nd Illinois Infantry. During his three years of

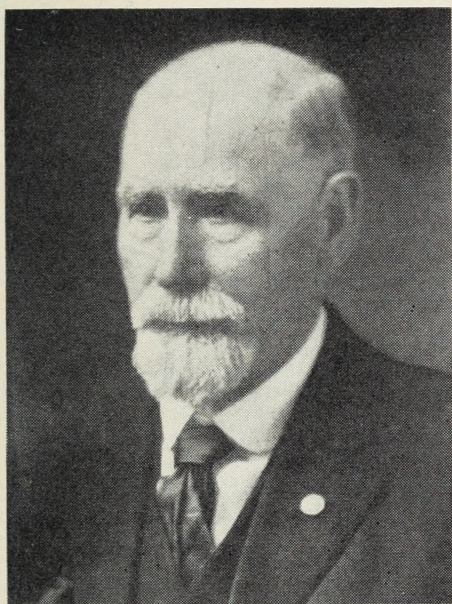

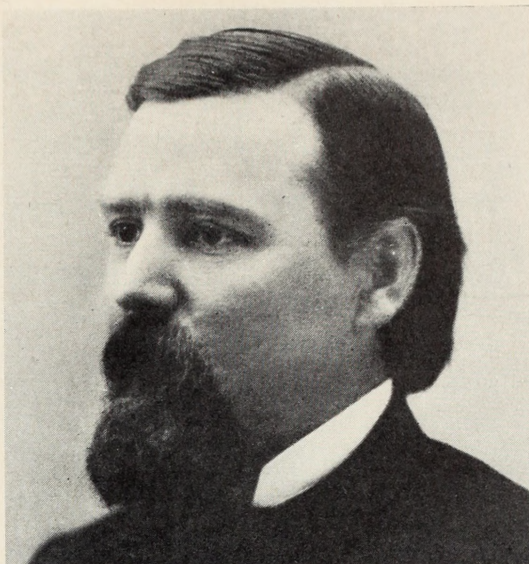


service, he took part in 63 battles and skirmishes, and at Peachtree Creek was the principal in an act of heroism under fire for which he was recommended for a medal. **W. E. McCREADY** was the next to the last veteran of the Civil War in Mount Morris to pass away. He was the son of John and Elizabeth McCready, was born Feb. 27, 1845, at Clinton, N.J., and died in Mount Morris, Sept. 25, 1934, aged 89½ years. He came to Mount Morris Township with his parents in 1850. At the early age of 17, he enlisted in the 14th Illinois Cavalry, and served to the end of the war. He returned to Mount Morris and married Sarah Nye, who died in the early eighties. Three children were born to them: John C., who died in 1920, Mrs. Vernie Spielman and Charles. In 1885, he married Elizabeth Marsh, and one son, Fred, was born to them. Mr. McCready was engaged in farming in the vicinity of Mount Morris for many years and served as road commissioner of the township for over 25 years.



**ROBERT D. McCLURE**, one of Mount Morris's best known citizens, died Feb. 5, 1903, aged 58 years. He was born at Pittsburgh, Pa., July 27, 1845, and spent his early life at Homestead, Pa. In 1865, he enlisted in Co. H, 2nd Pa. Inf. He came to Illinois in 1870, first locating at Haldane. In 1886, he purchased a farm one mile south of Mount Morris where he lived until his death. He was cashier of the bank at Forreton, supervisor from Lincoln Township, first president of the Board of Education of Mount Morris, was justice of the peace for twelve years, and cashier of the Bank of Mount Morris for nine years. Mr. McClure married Elizabeth Allen, Jan. 1, 1874, and they had four children: Robert R. McClure, attorney and farmer now living in Washington; Mary, former superintendent of Mount Morris High School; Maud, artist living in Mount Morris; Martha, wife of Hugh Allen, lieutenant commander, U.S. Navy, retired. Mrs. McClure passed away in 1927.

**CAPT. FREDERICK H. MARSH** came to Mount Morris in 1855 with his parents from Dover, England. He attended Rock River Seminary and at the outbreak of the war enlisted in Co. H, 15th Ill. Vol. Inf., but was later discharged because of illness. He recovered and reenlisted in Co. F, 46th Ill. Inf., and was promoted to captain in 1864. After the war he represented Ogle and Lee Counties in the State Legislature and was elected sheriff of Ogle County in 1882. In 1885, he was appointed U. S. 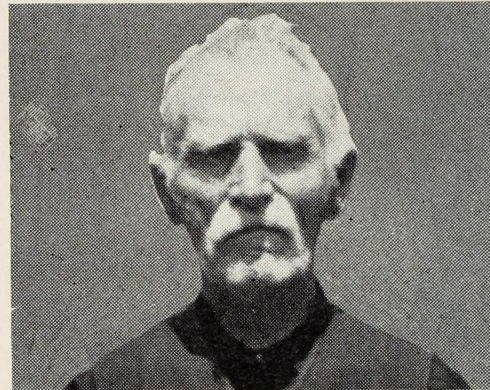

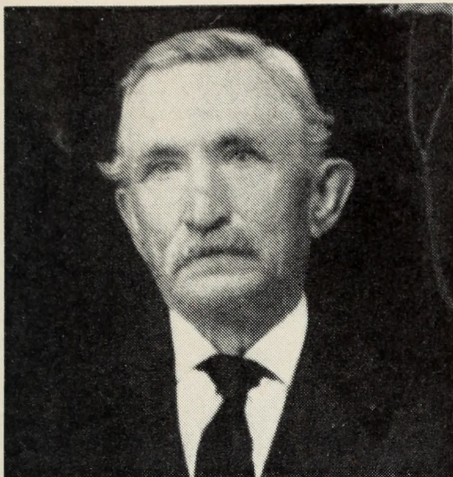
DANIEL RIDENOUR, son of John and Nancy Zellers Ridenour, was born at Hagerstown, Md., Nov. 6, 1836, and died in Mount Morris, June 25, 1928, aged nearly 92 years. During the Civil War, he served in Co. B, 2nd Pa. Artillery, from 1862 to 1865. Soon after the war he came to Mount Morris where he resided continuously for 60 years. In 1873, he married Susan Rowland and seven children were born to them. Only two of them survived the father, Mrs. E. D. Coddington and Mrs. David Paul. The mother died Apr. 7, 1910.

BENJAMIN H. RINE enlisted in Co. I, 140th Ill. Inf., and served until the end of the war. He was born in Cumberland County, Pa., January 5, 1845, and died in Belvidere, Ill., in February, 1933, aged 87 years. He lived in Mount Morris many years, engaged principally in the building business. In about 1880, he purchased the grocery store established by Wm. H. Bull and after several years sold to Holly Clark and Ira Wingert. At a later period he and his son-in-law, C. H. Whitman, conducted a meat market which they later sold to Wishard & Powell. Shortly before the war, he was married to Miss Melissa Fish, and four children were born to them: Myrtle (Mrs. John H. Miller), Anna M. (Mrs. C. H. Whitman), Fred and Eugene. JAMES H. STEVENS was the last veteran of the Civil War living in Mount Morris to pass away. On the following page is a picture of the veterans living in Mount Morris in the year 1900. At that time all of these veterans were past 60 years of age, and they gradually passed away one by one, until Mr. Stevens was the sole survivor, past 92 years of age. He was the son of David and Nancy Stevens and was born Nov. 15, 1843, at Waterfall, Pa., and passed away in Mount Morris Jan. 28, 1936. He enlisted in Co. M, 9th Pa. Cavalry, on Feb. 19, 1863, and served until the end of the war. While fighting at Stone River, his horse was shot from under him and he was seriously wounded at Lookout Mountain. In 1866 he married Margaret Ellen Carr and four children were born to them: Orion, Irvin, Virgie (Mrs. Cassius Crowell), and Carrie (Mrs. Fred Middlekauff). The family came to Mount Morris in 1877 and engaged in farming until 1906 when they moved to town. Mrs. Stevens died in March, 1918.

HENRY L. SMITH enlisted in 1863 in Co. D, 2nd Ill. Cav., at Rochelle and served until the close of the war. He was the son of John and Charity Smith, and was born at Warwick, N.Y., Feb. 28, 1831, and died March 8, 1915, aged 84 years. He came to Ogle County in 1857, locating at Flagg Center. He married Martha A. Brace in 1855, who died in 1862, leaving three young sons. On return from the war, he married Rebecca Holly in 1867, and moved to a farm in Mount Morris Township. His second wife died in 1875, leaving two children. He was married a third time in 1878 to Carrie L. Knodle, and to this union three sons and a daughter were born. When he died he was survived by his third wife and three sons: Henry Lee, Guy C., and Jesse H. After leaving the farm, he operated a livery stable in Mount Morris for a number of years.

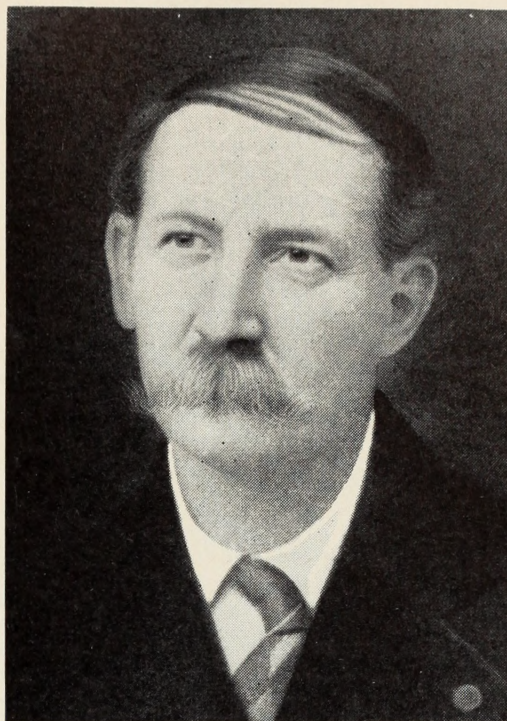

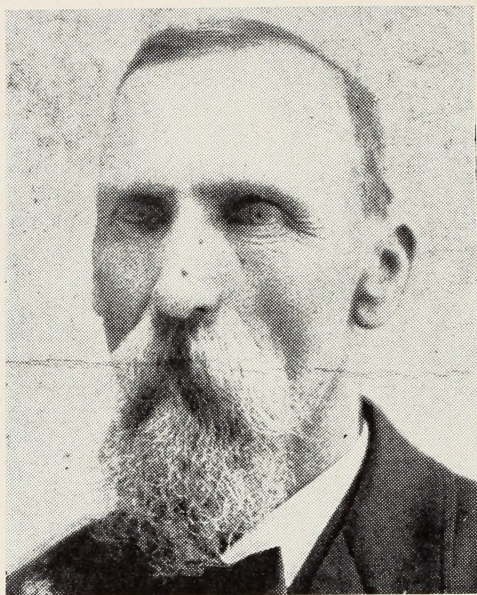

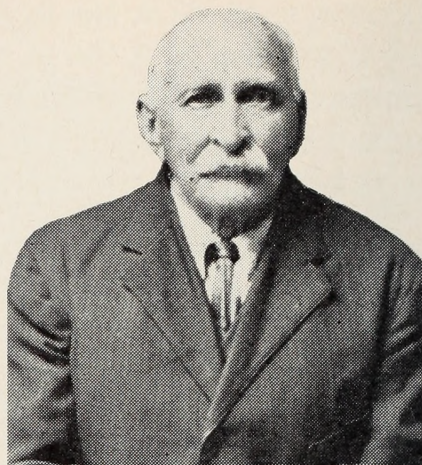

The old soldiers did not form a local organization for more than 25 years after the close of the war. The J. M. Smith Post, No. 720, Grand Army of the Republic, was chartered Aug. 22, 1891. The post was named in honor of J. M. Smith, who enlisted from Mount Morris and was killed Jan. 1, 1862, at the Battle of Stone River.

The first commander elected was Joseph M. Hosking, who served two and

one-half years. Following him, the commanders were as follows: Peter Householder, 1894-1895; R. D. McClure, 1896-1897; H. C. Clark, 1898-1899; J. T. Baker, 1900-1901; Wm. E. McCready, 1902-1903; F. ## SPANISH-AMERICAN WAR

AS FAR as is known, no one then living in Mount Morris enlisted in the Spanish-American War in 1898. However, a number of veterans of that war are now living in Mount Morris and others formerly lived here. The list compiled as accurately as possible is as follows:

Thomas I. Sprecher enlisted at Hagerstown, Md., in Co. B, First Md. Inf., and trained at Pimlico, Md. He was discharged Feb. 28, 1899, at Camp MacKenzie, Augusta, Ga., after 10 months' service.

Alvis Lawson enlisted from Tennessee, June 18, 1898, and was trained at Knoxville, Tenn. He served in Cuba

from November, 1898, to April, 1899, and was discharged May 6, 1899.

George W. Chaffee served in the Artillery Corps Band, 52nd Division. He died in Mount Morris in 1927.

John Granger served in Co. G, 8th Ill. Inf. He died in 1908.

Millman Tice, who served in the Spanish-American War, died in Mount Morris in 1924.

K. R. Leekley served in Porto Rico with Co. M, 6th Vol. Inf.

Edward H. McGee was a member of the 7th Cavalry and 15th Cavalry during the Spanish-American War. He was discharged in May, 1903.



## THE WORLD WAR

ON APRIL 6, 1917, the United States declared war on Germany and shortly thereafter Mount Morris boys began to volunteer for service in the army and navy. Then in June of the same year, under the conscription law, all males between the ages of 21 and 31 were required to register. In Mount Morris Township, 190 young men registered and eventually many of them were drafted into service. Before the war ended, nearly a hundred men were in the army of which about half were sent overseas before the armistice was signed. Of this number, not a single

**EARL ALLEN**—Son of Charles Allen, entered service Sept. 5, 1918, at Camp Forrest, Ga. Assigned to Engineers Replacement Corps and promoted to Sergeant. Discharged Jan. 9, 1919, after 4 months' service.

**HUGH ALLEN**—Lieutenant Commander, U.S. Navy (retired), was appointed to U.S. Naval Academy, Annapolis, Md., from Milwaukee, Wis., and served 15 years with the U.S. Navy. During the war he was C.O. of Naval Coast Patrol, Portland (Me.) Section; also on the Eligibility Board, Officers' School, Harvard University. He was later C.O. of Aviation Mechanics' School and 15th Regt., Great Lakes, Ill.

**FRANK H. AUFDERBECK**—Entered service May 25, 1918. Assigned to Co. A, 18th Inf., from Sept. 27 to Nov. 1, 1918, and transferred to Co. B, 2nd Machine Gun Battalion, Nov. 1, 1918. He saw active service in France and was with the Army of Occupation in Germany, being overseas from July 1, 1918 to Sept. 3, 1919. He was discharged in September, 1919, after 16 months' service.

**SYRIL AVEY**—Son of S. E. Avey. Entered United States Naval Academy at Annapolis, Md., in June, 1917. Saw service on U.S.S. Wisconsin and U.S.S. Kearsearge. Discharged Oct. 20, 1920.

**EUGENE BAKER**—Son of Frank Baker of Freeville, N.Y. Entered service May 25, 1918, at Camp Shelby, Hattiesburg, Miss., and assigned to Co. A, 113th Ammunition Train, motor section. In August, 1918, transferred to Medical Department of the 113th Ammunition Train.

**ROY J. BAKER**—Son of Edward Baker, entered service June 1, 1918 at Fort Thomas, Ky., and transferred to Camp Sheridan, Montgomery, Ala., where he was assigned to Co. C., 46th Infantry.

man was killed in action, although a number were wounded or gassed. However, four Mount Morris boys died of disease while in service, two of them while in camp in this country and the other two overseas.

The complete list of all soldiers and sailors who were in the service during the war is given here. This list includes not only those who enlisted or were drafted from Mount Morris, but also all present residents of Mount Morris who were in the service and who came here since the war.

**WILLIAM BARNHART**—Entered service April 27, 1918 with Co. D, 7th Ammunition Train, 7th Div. He was trained at Camp McArthur, Waco, Tex., attaining rank of Private 1st Class. He was overseas from May 25, 1918, to June 24, 1919, and was discharged June 27, 1919 after 14 months' service.

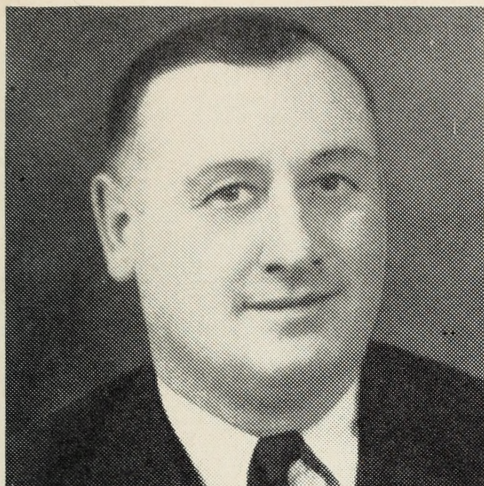
**MAX BARNHIZER**—Son of George Barnhizer, enlisted as mechanic in aviation service and sent in July, 1918 to Lewis Institute, Chicago, for instruction and training. In September, 1918, he was assigned as an assistant instructor. Discharged Dec. 9, 1918, after 5 months of service.

**PAUL BARNHIZER**—Son of Mrs. Mary Barnhizer. Entered service May 25, 1918, at Camp Shelby, Hattiesburg, Miss. Assigned to Co. C, 152d Infantry. In Sept. 1918, transferred to Camp Mills, N.Y., and arrived overseas in Oct., 1918. Was then transferred to Co. M, 327th Inf., 82nd Division.

**HOWARD BRONSON**—Served in the 4th Inf. Band, S. Dak. Nat. Guard, 1906 to 1908, and in the U.S. Navy as assistant band leader from 1909 to 1913. In the World War he was band leader of the First S. Dak. Cavalry, of the 307th Cavalry, Nat. Army, and the 51st Field Artillery. He was discharged in March, 1919. Since 1929 to the present he has been leader of the 129th Inf. Band, Ill. Nat. Guard, with rank of captain since 1933.

**OTHO BRUNER**—Son of Theodore Bruner. Enlisted in U.S. Marines and sent to Paris Island, S.C. Assigned to Co. 97, 6th Regiment and transferred to Quantico, Va. Forwarded to France in November, 1917. Slightly wounded on April 10, 1918. Again wounded on July 19, 1918. In October, 1918, returned home on furlough to recover from wound. Now living at Oak Park, Ill.





**LEON BEARD**—Son of Chas. Beard. Enlisted May 16, 1917, in Co. K, 3rd I.N.G., at Rockford. Sent for training to Camp Logan, Houston, Texas; transferred to Co. K, 129th Infantry, U.S.N.G. In November, 1917, assigned to Supply Co. Transferred in April, 1918, to Camp Upton, Long Island, N.Y. Sailed for France May 11th, 1918. In June, 1918, transferred to Machine Gun Co., 129th Infantry. Saw active service in the Amiens and Albert sectors and participated in Meuse Argonne offensive. Stationed after Armistice at Luxembourg with the Army of Occupation. Was discharged June, 1919, after 26 months service.

**ARTHUR S. BARRE**—Enlisted in 21st Engineers at Rockford. Sailed for France in Dec. 1917. Transferred to Co. M, 29th Engineers, and assigned to work in army printing office. Discharged in May, 1919, after 19 months' service.

**RAYMOND BICKFORD**—Son of Albert Bickford. Entered service and sent Oct. 15, 1918, to Northwestern University, Evanston, Ill., for special training in radio and sheet metal work. Now living at Polo, Ill.

**FRED BOEGEL**—Entered service at Louisville, Ky. He was trained at Charleston, S.C., and attained rank of corporal with 8th Anti Aircraft Battalion. He was discharged Dec. 20, 1918, after eight months' service.

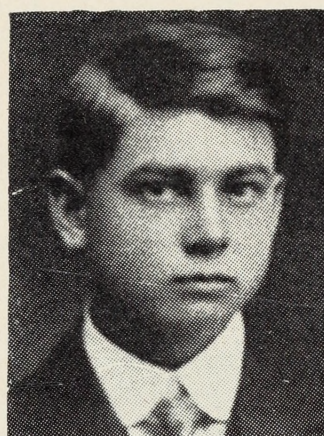

**BRYANT CHAMBERS**—Entered service with Co. L, 342nd Infantry, Camp Grant, Rockford, but later transferred to Camp Logan, Houston, Texas.

**EDWARD CHAMBERS**—Entered service in September, 1917, at Camp Grant, Ill., and assigned to Co. L, 342nd Infantry. Sent to France in September, 1918.



**RAYMOND BEARD**—Son of Wm. Beard. Entered service Sept. 5, 1918, at Camp Grant, Ill., and appointed corporal. Died of pneumonia at base hospital Nov. 7, 1918. Buried at Mount Morris.

**DONALD CLARK**—Enlisted in regular army May 7, 1917; discharged Aug. 14, 1919, Musician 1st Class. Served nearly two years overseas with 9th Inf., 2nd Div., as bandsman, during which time his regiment was in ten different sectors, including major engagements at Chateau Thierry, Soissons, Blanc Mont, St. Mihiel and Meuse-Argonne. He participated as stretcher bearer and runner at Soissons and Chateau Thierry, after which bandsmen were relieved of front line duty. On the Chateau Thierry front his regiment was under practically constant fire for thirty-five days. The 9th U.S. Inf. is one of the old and famous regiments of our country's military forces. It is interesting to note that William A. Newcomer, of the pioneer stock of Mount Morris, enlisted in the "9th" back in 1876, and served five years, during which time they often engaged in battles with Indians. The regimental flag was twice decorated during the World War by the French Government, which entitles its members to wear the French shoulder-cord decoration known as the *foutragere*.

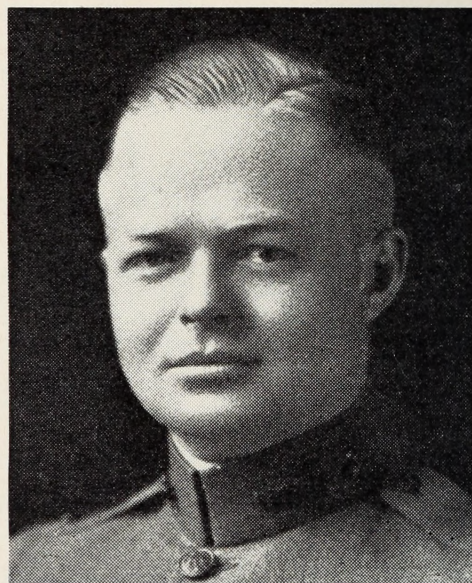


**ELMER CRIFE**—Son of D. S. Cripe. Enlisted in Aviation Corps. Preliminary training at the University of Illinois Ground School, Champaign, Ill. Transferred Dec. 15 to Waco, Texas, for actual flying practice. Completed training and received commission as Second Lieutenant. Transferred in April, 1918, to Camp Dick, Dallas, Texas. Arrived overseas in April, 1918 and engaged in advanced flying tests in France. Discharged Feb. 5, 1919. Now living in Rockford.

**RALPH CROWELL**—Son of Cassius Crowell. Enlisted in January, 1918, at Algona, Iowa, in Aviation Corps. Sent to Kelley Field, No. 1, San Antonio, Texas.

Transferred to 828th Aero Squadron, Selfridge Field, Mount Clemens, Mich. Transferred in April, 1918, to Hempstead Field No. 2, Long Island, N.Y. In June, 1918, again transferred to 218th Aero Squadron and arrived in France in July, 1918. In August transferred to 4th Air Squadron, 1st Pursuit Group. Discharged at Camp Grant in August, 1919, after 20 months' service.

**MERLE CULLER**—Son of D. D. Culler. Enlisted in the Engineering Corps., Sept. 2. Sent to Jefferson Barracks, Mo., and temporarily assigned to 16th Recruit Co. In October, 1918, transferred to Camp A. A. Humphreys, Va., and assigned to Hdq. Detachment, 7th Engineers Training Reserve. Again transferred to Co. E, 4th Eng. Training Reserve.



**CHARLES CUSHING**—Son of Mr. and Mrs. Harry Cushing. Enlisted in the Ordnance Department and commissioned first lieutenant. In February transferred to Chicago as inspector of ordnance. In July, 1918, assigned to tank corps, 303rd Co., and transferred to Camp Colt, Gettysburg, Pa. He was sent to France about a month before the armistice. Stayed in France at Tours in transportation service until June, 1919. His health was impaired while in service, from which he never recovered. He died in 1936.

**ALFRED DAVIS**—Enlisted at Benton Harbor, Mich. Assigned to Co. B, Selfridge Field, Mich., and was discharged Dec. 27, 1918, after 6 months' service.

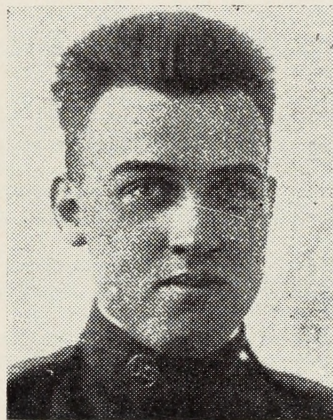

In Nov., 1918, he was transferred to Machine Gun Officers Training School, Augusta, Ga. Promoted to corporal and was discharged Dec. 20, 1918, after 19 months' service. Now lives at Decatur, Ill.

**WAYNE H. DIEHL**, son of Mrs. Rosa Diehl, enlisted in the U.S. Marines and was sent to Paris Island, S.C.; assigned to 6th Regiment, Headquarters Co., Quan-

tico, Va. Embarked for France Oct. 19 and landed in France on Nov. 1, 1917. After a period of training at several camps, Mr. Diehl's Company was sent to the front lines at Verdun on Mar. 14, 1918. Thereafter he participated in major operations of Belleau Woods, Chateau-Thierry, Soissons, Champagne and Meuse-Argonne. His company was awarded the French decoration, the *foutragere*, with four separate citations for gallantry. With the exception of one month, Mr. Diehl was in the lines from Mar. 14 to Nov. 3, 1918. During the Argonne drive he was evacuated to a hospital at Beaune. The remainder of his enlistment was spent at various hospitals in France and at Newport News and at Great Lakes, where he was honorably discharged July 26, 1919.
